

Rules and conditions of the promotion “Welcome bonus 7 USD”:

1. General provisions

- 1.1. The Promotion “Welcome bonus 7 USD” is arranged by OrangeFX Limited.
- 1.2. The Promotion will commence on 1.07.2018 and run until 1.09.2018.

2. Participants of promotion

- 2.1. The clients who have reached the age of 18 years can participate in the Promotion.
- 2.2. The terms of the Promotion apply to new clients of the Company registered the Personal Area during the Promotion run.
- 2.3. The employees of OrangeFX Limited, the Company partners and the relatives of person categories specified cannot participate in the Promotion.

3. Bonus receiving

- 3.1. To take a participate in the Promotion and receive “Welcome bonus 7 USD” the Client should follow the algorithm in interface (Wizard) containing several required steps:
 - 3.1.1. To register Personal Area and confirm email and telephone number specified while registering procedure.
 - 3.1.2. To complete the identity verification procedure.
 - 3.1.3. Open a Standard trading account with leverage 1:200 and USD account currency.
- 3.2. The bonus is deposited automatically to the trading account and is shown in Balance section of the trading terminal.
- 3.3. “Welcome bonus 7 USD” can be activated within 60 days. To activate the bonus the Client should make a trading transaction on the real account.

3.4. The bonus funds will be removed automatically if there is no trading activity on the account of Promotion participants within 60 days.

3.5. Subject to the clause 3.3 the bonus funds are on the Participant account termless.

3.6. If the Promotion participant has not used the Wizard but account conditions satisfy the requirements specified in the clause 3.1 the Participant may contact Customer Service Department and request the bonus via email: support@OrangeFX.com.

4. Trading conditions

4.1. The trade is fulfilled on the account type Standard with leverage 1:200 and USD as an account currency. To change leverage on the account with “Welcome bonus 7 USD” deposited are outlawed.

4.2. The trade is fulfilled via MetaTrader 5 platform.

4.3. Hedging and using others trading strategies based on opening of oppositely directed orders are outlawed.

4.4. To use trading advisers and non-judgmental trading systems are outlawed.

5. Profit withdrawal

5.1. The bonus funds and received profit from trading can be withdrawn by the Promotion participant at any time.

5.2. The first withdrawal fee for the accounts with bonus received is 100 USD, all other withdrawals will be processed without fee.

5.3. The minimum withdrawal sum is 1 USD.

5.4. The account can be deposited without any restrictions.

5.5. According to international legislation requirements for withdrawing profit the Client should verify his/her identity by uploading the scanned identification documents and the proof of residence in Personal Area.

6. Other essential terms

- 6.1. The Company reserves its right to refuse payment to the Promotion participant if the Client registered several Personal Areas on the website of OrangeFX Limited.
- 6.2. To trade using anonymous proxy server on the account of the Promotion participant is outlawed. The account will be disqualified if more than five connections to the real account will be disclosed and identified as different IP addresses appurtenant varied regions and/or countries.
- 6.3. Opening orders on an instrument with similar volume at the same time but with opposite direction are outlawed. The Organizer will cancel the bonus and transactions on the accounts if the Organizer detects identity and/or suspects some accounts including registered on different Participants of using this strategy.
- 6.4. The Company may decide at its own description whether variable deposits and accounts are connected with the Client, using for this purpose any methods which will be considered accepted.
- 6.5. If any apprehensions in abusive practice of the Promotion, swindling occur and also a forgery or document falsification provided by the Promotion participant is disclosed the account will be disqualified and the Client will be refused services.
- 6.6. The Company reserves its right to change the conditions of the promotions at any time and bonus specification and credentials as well (these changes are published on the official website of the Company in the News tab and apply retroactively).

- 6.8. The Company reserves its right to request any additional information (including the documents duly certified) required for proving the Participant's identity.
- 6.9. The Partner rebates for trading of the clients on the bonus funds under this Promotion are not paid. The Partner rebates are paid for trading of Clients upon condition that the Client deposited funds.
